ARTICLES OF INCORPORATION

OF

NAME

INITIAL BUSINESS

This corporation shall be a "non-profit corporation".

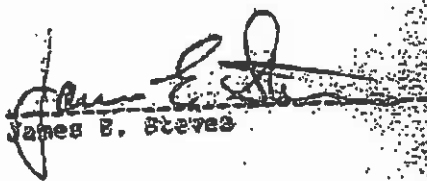

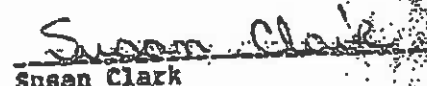
